RESOLUTION REQUESTING HIS EXCELLENCY PRESIDENT BENIGNO C. AQUINO III FOR FINANCIAL ASSISTANCE IN THE AMOUNT OF THIRTY MILLION PESOS (PhP30,000,000.00) FOR THE ROAD OPENING AND REHABILITATION OF BARANGAY KABANGKALAN TO BANGKITO AND TOMUGPA TO KAMANSI BARANGAY ROADS, ALL OF TUBURAN, CEBU.

WHEREAS, there is a need to open and rehabilitate some roads located in the municipality in order to provide easy transport of farm products from the mountain barangays down to the Poblacion area;

WHEREAS, considering the high costs that these projects would entail, the municipality has to seek outside financial assistance, specifically from the national government;

NOW, THEREFORE, on motion of Hon. Danilo M. Diamante and duly seconded by all Members present, it was

RESOLVED, as it is hereby resolved, to request His Excellency President Benigno C. Aquino III for financial assistance in the amount of Thirty Million Pesos (PhP30,000,000.00) for the Road Opening and Rehabilitation of Barangay Kabangkalan to Bangkito and Barangay Tomugpa to Kamansi Barangay Roads, all of Tuburan, Cebu;
