



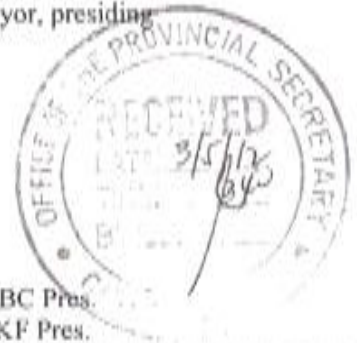

RESOLUTION NO. 2012-21

RESOLUTION ENACTING AN ORDINANCE IMPOSING ON ALL NBI CLEARANCE SECURED FROM THE NATIONAL BUREAU OF INVESTIGATION EXTENSION OFFICE AT TUBURAN, CEBU AN ADDITIONAL FEE OF FIFTEEN PESOS (P15.00) FOR LOCAL REQUIREMENT AND TWENTY PESOS (P20.00) FOR FOREIGN REQUIREMENT, WHICH SUM SHALL ACCRUE TO THE GENERAL FUND OF THE LOCAL GOVERNMENT UNIT OF TUBURAN, CEBU.

WHEREAS, the Local Government Unit of Tuburan, Cebu, in coordination with the National Bureau of Investigation (NBI), has set up an Extension NBI Office at Tuburan, Cebu to cater the ever-increasing applicants for NBI Clearance;

WHEREAS, to recoup whatever expenses that the municipality has put into the operation, it is but necessary to impose charges or fees in addition to what is presently being charged thereon;

NOW, THEREFORE, on motion of Hon. Danilo M. Diamante and duly seconded by all Members present, it was

RESOLVED, as it is hereby resolved, to pass the following Ordinance, to wit:

ORDINANCE NO. 77

AN ORDINANCE IMPOSING ON ALL NBI CLEARANCE SECURED FROM THE NATIONAL BUREAU OF INVESTIGATION EXTENSION OFFICE AT TUBURAN, CEBU AN ADDITIONAL FEE OF FIFTEEN PESOS (P15.00) FOR LOCAL REQUIREMENT AND TWENTY PESOS (P20.00) FOR FOREIGN REQUIREMENT, WHICH SUM SHALL ACCRUE TO THE GENERAL FUND OF THE LOCAL GOVERNMENT UNIT OF TUBURAN, CEBU.

Be it ordained by the Sangguniang Bayan of Tuburan, Cebu that:

SECTION 1. There is hereby imposed on all NBI Clearances secured from the National Bureau of Investigation Extension Office of Tuburan, Cebu an additional fee, to wit:

For Local Requirement = P15.00
For Foreign Requirement = P20.00

SECTION 2. All fees collected pursuant to Section 1 hereof shall accrue to the General Fund of the municipality.


SECTION 3. This Ordinance shall take effect immediately after its approval.
