WHEREAS, typhoid cases in the municipality of Tuburan has soar up to the point of outbreak, causing deaths and severe illness to its populace;

WHEREAS, the increasing cases has caused an alarming effect and there is a need for an immediate action to be taken in order to contain the disease;

WHEREAS, there is a need to declare the whole municipality in a state of calamity in order to use its Calamity Fund to purchase the necessary supplies and materials to address the problem and to monitor, prevent and control overpricing/profitteering and hoarding of prime commodities, medicines and other basic products within the area;

NOW, THEREFORE, upon unanimous acclamation of all Members present and duly seconded by same, it was

RESOLVED, as it is hereby resolved, to **DECLARE THE ENTIRE MUNICIPALITY OF TUBURAN, CEBU IN A STATE OF CALAMITY** due to the typhoid outbreak in the area;




RESOLVED FURTHERMORE, to furnish copies of this resolution to all Barangay Councils of Tuburan, Cebu for their information and guidance.
